The operative part of the contract at issue is the 1.5 percent commission provision of paragraph 6.1. In providing for the payment of 1.5 percent commission to Morris, the agreement, by and between ZBI and Land's Edge, required that the commission be paid in "Xerox One hundred (\$100.00) and no more Dollars." The writing, however, provides no additional terms or payment amounts. Without a detailed account of the commission payment amount, a trier of fact could not accurately evaluate the terms of the contract at issue. Therefore, a genuine dispute of material fact exists as to whether a contract was formed. Moreover, the parol evidence rule may be applicable. The parol evidence rule bars evidence of prior or contemporaneous oral agreements or understandings to contradict the terms of a contract. Id. at 143; see generally, section 400.2-202, RSMo 2000. In order for the parol evidence rule to be applicable, however, there must be a completed contract. A contract is "completed" when the parties have so far reached a mutual understanding on the subject matter that there is a binding commitment on the part of each party to the contract to act or to abstain from acting in accordance with its terms, and when the parties have so far performed their promises that each is obligated to render a promised performance. This one's still grammatical, but it suggests some kind of odd philosophical paradox: if I wanted to talk about a problem, I'd talk to a client, and I guess that 'client' would be
